Compliance Monitoring Unit (AB 436 amended SBX2-9). Compliance monitoring and enforcement responsibilities prescribed by Labor Code Section 1771.55 all applicable regulations shall be performed by the Department of Industrial Relations (“DIR”) Compliance Monitoring Unit (“CMU”) within the Division of Labor Standards Enforcement (DLSE) in the pursuant to Labor Code § 1771.75 and in accordance with 8 Cal. Code Reg. 16640, *et seq.* The functions carried out by the Compliance Monitoring Unit shall be in addition to and shall not limit or supplant the other public works investigation and enforcement responsibilities and authority of the Labor Commissioner and the Division of Labor Standards Enforcement under any other statute or regulation.
