**NOTICE IS HEREBY GIVEN** that the Rowland Unified School District of Los Angeles County, California, acting by and through its Governing Board, hereinafter referred to as the District, will receive sealed proposals up to **10:00 A.M., April 19, 2018**, for the award of contract for:

Compliance Monitoring Unit (AB 436 amended SBX2-9). Compliance monitoring and enforcement responsibilities prescribed by Labor Code Section 1771.55 all applicable regulations shall be performed by the Department of Industrial Relations (“DIR”) Compliance Monitoring Unit (“CMU”) within the Division of Labor Standards Enforcement (DLSE) in the pursuant to Labor Code § 1771.75 and in accordance with 8 Cal. Code Reg. 16640, *et seq.* The functions carried out by the Compliance Monitoring Unit shall be in addition to and shall not limit or supplant the other public works investigation and enforcement responsibilities and authority of the Labor Commissioner and the Division of Labor Standards Enforcement under any other statute or regulation.

**A Mandatory Pre-Construction Conference** will be conducted on **March 28, 2018, at 10:00 A.M.** Interested bidders are to meet in the parking lot at the **Ruth Richard Food Center, 4032 S.
